Sir,

In producing herewith arrested accused Vola Sarkar @ Pradip Sarkar (M/41 yrs), S/O- Premananda Sarkar of Vill- Nityanandapur, P.O. – Radhamohanpur, P.S- Sonamukhi, Dist- Bankura along with seized articles i.e. 23 bottles Country spirit, styled as "CAPTAIN", each bottle quantity 600 ml., Total amount | Rs.100x23=Rs. 2300/-] from which one bottle taken as sample.

I, ASI. Suresh Mahadani of Sonamukhi PS do hereby lodge a suo-moto complaint to the effect that today i.e. on 30/07/21 during my mobile patrolling duty vide C.C. No- 2727/21 & GDE No-1644/21, Dt-30/07/21, myself alongwith C/72 Baren Ch. Murmu, C/617 Milan Kanti Sinha and NVF/810 Chinmoy Das while on duty, received source-information that Vola Sarkar @ Pradip Sarkar (M/41 yrs), S/O- Premananda Sarkar of Vill- Nityanandapur, P.O. – Radhamohanpur, P.S- Sonamukhi, Dist- Bankura has been selling country spirit in his Hotel styled as "MA TARA HOTEL" at village Nityanandapur under PS Sonamukhi without any license since long. Accordingly I informed the matter to I/C Sonamukhi PS and as per his kind direction myself along with force left for village Nityanandapur to work out the information.

At about 20.35hrs. reached at village Nityanandapur and with the help of my source, identified the "MA TARA HOTEL" of said Vola Sarkar. Keeping the Police vehicle at a distance, myself along with force, in full uniform, reached at the Hotel of Vola Sarkar and found the said Vola Sarkar @ Pradip Sarkar was selling Country Spirit in lieu of money to the customers but seen the police party all of them started to run away from the place, we also chased them and managed to catch said Vola Sarkar @ Pradip Sarkar. On asking he disclosed his above noted name and address. I shared the information which we had with us. I also offered him to search our persons but he replied in negative. After that I searched his "MA TARA HOTEL" in presence of him and witnesses and found 23 bottles Country spirit, styled as "CAPTAIN", each bottle quantity 600 ml., Total amount [Rs.100x3=Rs. 300/-] in his Hotel, in a secret place. On further asking about the said country sprit bottles, he admitted that he used to sell country spirit to run his family as he is very poor. On asking about license in respect of selling country spirit, he could not produce any valid documents or license. So, I seized and labeled the said 23 bottles country spirit as per seizure list in front of accused person and witnesses. I requested the local people who were present on the spot to sign in the seizure list as witness but all of them refused to sign in the seizure list. So, my accompanied force put signature in the seizure list. After that I arrested him maintaining all legal formalities regarding arrest set by Honable Apex Court.

Under the above circumstance, I request you to start a specific case against the said Vola Sarkar @ Pradip Sarkar (M/41 yrs), S/O- Premananda Sarkar of Vill- Nityanandapur, P.O.-Radhamohanpur, P.S- Sonamukhi, Dist- Bankura under proper section of law.
