Respected Sir,

In producing herewith seized article i.e. 20 (twenty) liters I.D. liquor in a plastic container (Jericane) I do hereby submit complaint against accused Adan Hembram (50years) S/O Lt. Mangal Hembram of vill- Jagarnathpur Rasthapara P.O + P.S - Simlapal, Dist. Bankura to the effect that on 21.08.2021 at about 11.15 hrs as per source information and as shown by local Civic volunteer force I located the house & held raid at Jagarnathpur Rasthapara P.O + P.S - Simlapal, Dist-Bankura and found one person preparing illicit I/D liquor in his house. On seeing police party he fled away from that house as identified by accompanied local Civic Volunteer force he was owner of this house namely Adan Hembram (50 years) S/O Lt. Mangal Hembram. I tried apprehend the above noted the house owner but could not trace out. Found that I/d liquor and other related articles were found in the premises of his house ,it can be said beyond doubt that I/D liquor was getting prepared there illegally .On called no family members found there. So in between 11.25 hrs to 11.55 hrs I seized 02 (two) plastic made 10 (ten) ltrs. container loaded with approx 10 (ten) ltrs . liquid appearing to have been illicit liquor and taken sample from both seized container in a 375 ML bottle and destroyed their following articles 1) 04(four) plastic made container loaded with Molasses (2) Fermented wash loaded in a 03 (three)plastic made container approx 15 kgs each container & (3) One earthen distillatory apparatus.

So, I pray before you to start a case under proper section of law against accused Adan Hembram (50years) S/O Lt. Mangal Hembram of vill- Jagarnathpur Rasthapara P.O + P.S - Simlapal, Dist. Bankura and arrange for its investigation.
