Sub- Complaint for lodging FIR against arrested accused -1. Amirrudin Khan @ Lulu (24 Yrs) S/O- Azijul Khan @ Aizul @ Azu of Vill- Kharkusma, Shapara PS- Garbeta, Dist- Paschim Medinipur under proper section of law

Sir,

I, PSI Animesh Mahata of Bishnupur PS producing here with 01 arrested accused person namely Amirrudin Khan @ Lulu (24 Yrs) S/O- Azijul Khan @ Aizul @ Azu of Vill- Kharkusma, Shapara PS- Garbeta, Dist- Paschim Medinipur, along with the seized Motor Cycle, HERO HONDA Passion, Colour, Black in colour without any number Plate having Ch No- 02K21C27573 Eng No-02K21M27141 details are in seizure list [enclosed] and beg to submit that, I was engaged in High way mobile duty on NH-60 (Bishnupur-Kharagpur) as scheduled (This refers to GDE no-483 & CC no-2538/21 Dt- 10.08.21). At about 18.15 hrs, received source information from VP- Hannan Khan of Morar GP, that one trying to sell one Motor Cycle as noted above to a Scrap Shop keeper namely Dipak Mondal S/O Barik Mondal at 3 No- Camp, Morar, Bishnupur, when he denied to buy it, at that time one duty CVF followed him and tried to apprehend him but aforesaid persons trying to escape by riding the aforesaid Motorcycle towards Bankadaha on NH- 60. Immediately aforesaid CVF inform me over phone that one suspected motor Cycle rider escaping towards Bankadaha side.. According I chased him on the Road and able to stop him the aforesaid suspected accused with Motor Cycle. When ask him to produce the paper documents of the aforesaid motor Cycle and his identity, but only he disclosed his name and address but failed to produce any document in respect of the Motor Cycle. Then I brought him to Scrap Shop of Dipak Mondal for verifying the fact of sale, who corroborated with the fact as noted above. Accordingly I seized the aforesaid Motor Cycle without any number plate having Ch No- 02K21C27573 Eng No-02K21M27141 under proper seizure list duty signed by the suspected accused. After that I arrested aforesaid accused and witnesses person maintaining all legal formalities of arrest with a view to prosecute him U/S 379/411 IPC and brought him to PS.


Therefore, I pray before you that one specific case may kindly be started against arrested accused persons 1, Amirrudin Khan @ Lulu (24 Yrs) S/O- Azijul Khan @ Aizul @ Azu of Vill- Kharkusma, Shapara PS- Garbeta, Dist- Paschim Medinipur U/S 379/411 IPC for its regular investigation.
