Sir,

I, ASI Ranjit Kr. Pain of Bishnupur PS producing here with 02(two) arrested accused persons namely 1) Chandra Mohan Gorai (34 Yrs) S/O Sri Bhim Chandra Gorai of Satyapir Tola (Pokabandh Uttarpar) W No- 9, PS- Bishnupur Dist- Bankura 2) Subrata Mondal (48 Yrs) S/O Sri Sisir Kr Mondal of Jhaparmore, Station Rd, W No-19, PS- Bishnupur Dist- Bankura along with the seized paper documents viz- 05+02=07 (sets) of Blank Form of Application of "LAKSHMIR BHANDAR SCHEME" Govt of West Bengal, with logo of "Biswa Bangla" seizure list (enclosed) and beg to submit that, I was engaged in day mobile duty in Bishnupur Town area as scheduled (This refers to GDE no-592 & CC no-2561/21 Dt- 12.08.21), At about 13.05 hrs received information from reliable source that some of the Xerox centre/shops of Town area selling Blank Form of Application of "LAKSHMIR BHANDAR SCHEME" Govt of West Bengal, with logo of "Biswa Bangla" among local people in lieu of cash fraudulently.

Accordingly, I informed the matter to IC Bishnupur PS and as directed I along with force held raid in several Xerox centre/shops and found that 02 numbers of Xerox centre/shops styled as 1) NET WORLD situated at Pokabandh Uttarpar & PARIVAR situated at Jhapar More respectively selling Blank Form of Application of "LAKSHMIR BHANDAR SCHEME" Govt of West Bengal, with logo of "Biswa Bangla" in lieu of cash. On being asked to the owners of the shops about the procurement and authentication of its selling among the people but both the owner failed to produced and document in respect of selling of the Govt form as noted above. I interrogated both of them thoroughly, who admitted that they procured all the forms as noted above from the Web- Net and selling to people in lieu of cash to economical gain.

From the above fact and circumstances, it was confirmed that the owners of the NET WORLD & PARIVAR shops were procured fraudulently by any mean and used it as genuine and there by cheated to innocent persons. Having no alternation I seized all the alleged forms from their shops under proper seizure list duly signed by the owners and the available witness from 14.00 hrs -14.25 hrs at Pokabandh and 14.45 hrs -15.05 hrs at Jhapar More and finally arrested both of them after disclosing them grounds of arrest and maintained all formalities and brought them to PS.

Therefore, I pray before you that one specific case may kindly be started against arrested accused persons 1) Chandra Mohan Gorai (34 Yrs) S/O Sri Bhim Chandra Gorai of Satyapir Tola (Pokabandh Uttarpar) W No- 9, PS- Bishnupur Dist- Bankura 2) Subrata Mondal (48 Yrs) S/O Sri Sisir Kr Mondal of Jhaparmore, Station Rd, W No-19, PS- Bishnupur Dist- Bankura accused persons under proper section of law
