Sub: Specific complaint against the owner cum driver of tractor bearing No- WB 67B/4141 for illegal possession and transportation of Sand.

Sir,

In producing herewith 01 tractor bearing No-WB 67B/4141 loaded with some amount of sand with arrested accused owner cum driver namely Bivas Ghosh [M/25 yrs] S/O-Niren Ghosh of Vill-Sonatapal. P.S-Onda, Dist-Bankura. I beg to submit that on 19.08.2021 while myself along with C/267 Nayan Rajak, C/621 Lakhi Kanta Chel. NVF/0814 Bidyut Mahanta vide C.C No-1505/21 dt 19.08.2021 was engaged in mobile duty at Onda P.S area. On 20.08.2021 at about 02:15 hrs received an information through duty officer regarding illegal transportation of sand through Darakeswar river to Bandhbhanga moram road. This information has been diarized at Onda PS vide GDE No- 888 dtd. 20.08.2021 and as per direction of O.C. Onda PS myself along with force started movement on the road on 20.08.2021 at 03.35 hrs intercepted 01 tractor bearing No- WB 67B/4141 loaded with sand. During persuasion 01 driver of the tractor was found on the staring of his respective tractor. Seeing Police, the driver of the said tractor stopped his tractor in between Bandhbhanga & Tapaban Raghunath Jue Mandir and tried to flee away from the spot after unloading half amount of sand, but some sand found with the said tractor. Myself along with force chased we could manage the apprehend the driver. On interrogation the driver disclosed his identity as Bivas Ghosh [M/25 yrs] S/O-Niren Ghosh of Vill-Sonatapal, P.S-Onda, Dist-Bankura.

On being search I could not find any papers at the said tractor over the sand transportation. It is crystal clear that he has loaded sand in his tractor by any fraudulent means after stealing it from sand stock point which transportation in the Covid Pandemic situation. So, I seized the said tractor loaded with some amount of sand as per seizure list and arrested the accused driver after all legal formality of NHRC guidelines of the apex court.

Sir, I could also come to know that the accused driver is a habitual offender of such type of crime as previously he is involved in Onda PS Case No-113/2021 dt 05.07.2021 U/S-379/411/188/ IPC & Section 21 of Mines & Minerals (Development & Regulation) Act 1957 & Section 51 (b) of Disaster Management Act 2005.

Hence, I prayed to you kindly start a specific case in against him and take action as per law.
