Sir,

In producing herewith, the accused [1] Matikul Khan [M/49 yrs] S/O-Lt. Sahar Ali Khan (2) Saharuk Khan [M/19 yrs] S/O-Sattar Ali Khan both of Ashrampara, Kethardanga, P.S+ Dist-Bankura and seized articles i.e. 02 goats' seizure as alamat.

I would like to draw your kind attention to the fact that I PSI Krishna Murmu along with force engaged in mobile duty. During mobile duty received information from secret credible source that a vehicle bearing Regd. no-WB34AZ/9464 loaded with goat coming from Bishnupur side through NH-60 road. Accordingly, I informed the matter to O/C Onda PS and diarized the same in PS GD Book Vide Onda PS GDE NO-1037 As per kind direction of O/C Onda PS Myself alongwith C/1020 Pallab Bisui, C/1188 Nirodh Baran Gope, HG-RBD/82 Jhantu Shit vide C.C no-1531/21 dt 22.08.2021 started movement on the above noted road at 12.55 hrs near Malpur. Ramsagar found one ALTO bearing no-WB34AZ/9464 coming from Bishnupur side with an excessive speed. I along with force try to stop the vehicle by proper Police signal. but the driver did not stopped his vehicle. After a hot chased, we could manage to stop the vehicle near Deshband more. Myself along force searched the vehicle and found 02 goat inside the vehicle. I asked the driver & one passenger about the goat but they give different statements in different time. On interrogation they disclosed their identity [1] Matikul Khan [M/49 yrs] S/O-Lt. Sahar Ali Khan (2) Saharuk Khan [M/19 yrs] S/O-Sattar Ali Khan both of Ashrampara, Kethardanga, P.S+ Dist-Bankura. They also stated that 02 goats stolen form nearest village and sell the goats for collect money. I prepared seizure list duly signed by the witness. I could not get any public witness as the time of seizure the public witness did not present there. So, my accompanied force put their signature in the seizure list.

Accordingly, I arrested the above noted two accused persons namely [1] Matikul Khan [M/49 yrs] S/O-Lt. Sahar Ali Khan (2) Saharuk Khan [M/19 yrs] S/O-Sattar Ali Khan both of Ashrampara, Kethardanga, P.S+ Dist-Bankura after maintain all legal formalities guided by NHRC rule. I supplied a copy of seizure list as well as copy of Arrest Memo to the arrested accused persons after obtaining their signatures.

On my arrival back to P.S. with two arrested accused persons with the seized alamat, I produced them before you for starting a specific case against all the accused persons noted above who all are verified to be notorious criminals of the area. Kindly arrange its investigation & oblige.
