Getting the information of theft of electricity, on **27.08.2021** between 13:55hrs – 14:20hrs the undersigned along with Sri Sitaram Banerjee,S/O Lt.Niranjan Banerjee, Special Officer (S&LP) Bankura Regional Office, WBSEDCL, Lalbazar, Bankura,Sri Shantanu Mukherjee, A.E. & S.M.,Onda CCC,WBSEDCL,Sri Kousik Chowdhury, JE(GR-I),OndaCCC, Sri Rakesh Patra, O.E. Onda CCC and staffs of LT mobile van of Onda CCC inspected the domestic premises of Asish Dey, duly identified by source and also inspected the nearby LTOH line of WBSEDCL.

During inspection it was detected that user accused was committing theft of electricity by way of direct hooking from nearby LTOH line of WBSEDCL for the purpose of his domestic use which is clearly violation of electricity rule. The undersigned prepared inspection report on the spot and assessed the consumption of load which was detected as 1.9 KW.
