Sir,

In producing here with one tractor bearing registration no.-WB88C-8631, Model Swaraj744FE, engine No-433008/SYG18220 & Chassis No- WSCG40922174875 loaded with sand approx 100 cft. with its driver namely Sourav Basuli S/O- Pradip Basuli of vill- Banskopa, P.S-Taldangra, Dist-Bankura, I hereby lodge complaint to the effect that in course of mobile duty in P.S area vide GDE No-538 & C.C No- 1794 dt.-14.08.21 at 16:35 hrs near Kusumdungri, I had information on 15.08.21 at about 04:45 hrs from local source of illegal collection of sand from stock at the house of Sourav Basuli of Banskopa village towards Pathordoba through village road and when rushed at Pathordoba morh near Kabarsthan and found at about 05:35 hrs that one driver is driving the vehicle full of sand towards Simlapal side. I caused him to stop I wanted to know about the valid permission/documents but he could not produce any valid permission/documents in respect of transporting the said sand. He revealed that carrying sand in conspiracy with owner of the tractor from his house stock for selling at Pathordoba village under Simlapal P.S area. On enquiry, I could know that the driver namely Sourav Basuli S/O- Pradip Basuli of the said tractor used to carry sand almost regularly from stock of sand at his house at Banskopa under P.S Taldangra without any valid permission/documents violating the provision of Mines and Minerals (Development and Regulation) Act, 1957 and Govt. order relating to Disaster management Act. As such I have seized the tractor fully loaded with sand in between 06:15 hrs and 06:45 hrs as per seizure list duly signed by the witnesses and I arrested the driver at about 06:55 hrs of the said tractor namely Sourav Basuli S/O- Pradip Basuli of vill- Banskopa, P.S-Taldangra, Dist-Bankura.

Under above circumstances a specific case may kindly be started accused (1) Driver & (2) the owner of the tractor bearing registration no.-WB88C-8631, Model Swaraj744FE, Engine No-433008/SYG18220 & Chassis No- WSCG40922174875 loaded with sand approx 100 cft. under proper section of law.
