Sir,

In producing here with the arrested person namely Uttam Pal (39Y) S/O- Kartik Pal of Telenda PO- Purunia PS- Mejia Dist- Bankura along with seized one Blue & White colour tractor having no WB 68X/4701, Model – Swaraj 735 FE with Yellow & Blue colour trolley loaded with sand 100 cft approximately.

Today i.e. on 29.08.2021, I, ASI/435 Tarun Kumar Halder of Beliatore PS along with C/1359 Dhriendra Nath Mahato, C/1588 Rajib Panda and NVF/0722 Chiranjit Senapati as per order of O/C Beliatore PS performing mobile duty in Beliatore PS area, vide GDE no-1020 date- 29.08.2021 and CC no-1472 /21 date- 29.08.2021. During my said duty at 14:15 hrs I received information from a credible local source that a tractor coming from G-Ghanti side, loaded with sand illegally. At 14:45 hrs I reached at Kataboni more and found that 01 (one) Blue & White colour tractor bearing registration no- WB 68X/4701, Model - Swaraj 735 FE with Yellow & Blue colour trolley loaded with sand 100 cft approximately coming from G-Ghanti side. On seeing Police the driver of the said tractor tried to flee away. But somehow we managed to apprehended him with the tractor loaded with sand. On interrogation he stated his particulars namely Uttam Pal (39Y) S/O- Kartik Pal of Telenda PO- Purunia PS- Mejia Dist- Bankura and he is the driver cum owner of said tractor. On demand he failed to produce any valid license or documents in support of his possession of the said tractor with trolley and the loaded sand in it. Accordingly, I seized the above noted tractor and trolley loaded with sand and arrested him.

Under the above fact and circumstance, I request you to start a specific case under proper section of law against the said Uttam Pal (39Y) S/O- Kartik Pal of Telenda PO-Purunia PS- Mejia Dist- Bankura and arrange for its investigation.
