In producing herewith one arrested accused person namely Shyamlal Murmu (38Y), S/o- Lt. Brindaban Murmu of Bankati, PS- Bishnupur, Dist- Bankura along with seized article 1) containing 10 bottle CS styled as "CAPTAIN" 60^o up 600 ml each duly sealed and labeled by me, I ASI Sukhendu Panja of Bishnupur PS do here by lodge complaint against one Shyamlal Murmu (38Y), S/o- Lt. Brindaban Murmu of Bankati, PS- Bishnupur, Dist- Bankura to the effect that on 21.08.21 at about 18:25 hrs received secret information over telephone from duty officer of PS that illegal selling of ID liquor is going on at the house of Late Poran Murmu by Shyamlal Murmu of villagr Dwadashbari, Morar PS- Bishnupur, Dist- Bankura. (This ref. to Bishnupur P.S. G.D.E. no- 926, Dt.- 21.08.21) Accordingly as per order of IC, Bishnupur PS, I accompanied by force namely C/414 Fatik Ch. Kar, C/168 Gouranga Patra left for Dwadashbari, PS- Bishnupur, Dist- Bankura to work out the information and held raid in the house of Late Poran Murmu at village Dwadashbari, PS- Bishnupur, Dist- Bankura at about 19:05 hrs on seeing Police party some persons who were sitting in the courtyard of his house and taking liquor, started to flee away. We chased behind them. But all of them except Shyamlal Murmu failed to escape. I called some disinterested persons. In presence of some villagers and police personnel in between 19:25 hrs to 19:35 hrs searched the hotel from where those persons fled away and found 1) containing 10 bottle CS styled as "CAPTAIN" 60^o up 600 ml. On local enquiry I came to learn that the accused Shaymlal Murmu selling liquor illegally from his house and he has been running this illegal business since long. I arranged to collect one bottle of CS as a sample from each and sealed, labeled, and seized the same in presence of police witnesses under proper seizure list duly signed by them. On several requests no villagers came forward to sign in the seizure list. The seizure of the above articles was made in between 19:25 hrs to 19:35 hrs duly Signed by the accused person. I interrogated him thoroughly then he confessed his guilt. Accordingly I arrested the accused person namely Shyamlal Murmu (38Y), S/o- Lt. Brindaban Murmu of Bankati, PS- Bishnupur, Dist- Bankura. The approximate value of the article seized and destroyed is Rs 1000/- only.

Under the above circumstance, I request you to start a specific case against the said Shyamlal Murmu (38Y), S/o- Lt. Brindaban Murmu of Bankati, PS- Bishnupur, Dist- Bankura and arrange for its investigation.
