Sub: Prayer for lodging FIR.

Sir.

With due respect I, SI Subham Roy Chowdhury of Bishnupur PS do here by producing one Habibul Gayen (31 Yrs) @ Chutu S/o Lt Khilafat Gayen of vill Mahan Pur , PS Garbeta, Dist .- Paschim Medinipur and the following seized articles ie, (01) One improvised country made pipe gun which measures around 17 cm diagonally having a hammer, trigger, pistol grip and firing pin and (02) One .303 live cartidge which was fitted inside the above noted fire arms and later taken out do here by lodge this written complaint that today myself along with force when performing Evening mobile duty along with force C/424 Banamali Mallick and NVF-Sukomal Hembram both of Bishnupur PS vide CC No. 2906/21, Dt. 21.08.21 and during performing such duty at about 18:25 hrs received secret information that some persons assembled near Chowkan more for committing some untoward incident. Working out the information at about 18:35 hrs when I reached Chowkan more pitch road. I found some persons starting running after observing the police van and after a while reaching the close proximity after a hot chase we able to apprehend the above noted person. During search we found one improvised country made pipe gun which measure around 17 cm diagonally, having a hammer trigger, pistol grip and firing pin and One .303live cartridge which was fitted inside the above noted fire arms in the right side of his waist. On being asked he failed to produce any legal paper, license against the arms and ammunition and give any satisfied reason of having the same of carrying the same. Subsequently I seized the arms and the ammunition from 18:45 hrs to 19:25 hrs from the exclusive possession of Habibul Gayen duly signed by the witnesses and the accd person and prepared the label of the same . During seizure some of the local people who were observing all of our exercise requested to put their signature in the seizure list but they avoid to become a witness of the fact to avoid police and force harassment. During primary interrogation of the accused person he confessed that around 10/11 days ago he along with other miscreants assembled near the jungle based area under Bishnupur PS jurisdiction and committed robbery in respect of Liquid cash, Mobile Phone, Money etc. When being asked about the source of procurement, possession, transit of delivery point of the said Arms and ammunition he kept mum on the matter.

Thereafter i arrested him at chowkan morh after maintaining all formalities of arrest as per the NHRC and apex court guidelines. On study of circumstances it is primarily established that the above noted accused person has virtually committed the offence punishable under arms Act.

Henceforth I submit this typed complaint against him and his other accomplice and I pray that a cognizable case under proper section of law may kindly be started against the above noted accused person and oblige.
