I, Anup Kumar Mandal S/O-Sri Sahadeb Mandal, Station Manager, Chhatna C.C.C, WBSEDCL being authorized under the electricity Act'2003 and electricity (Amendment) Act'2007 do here by lodge complaint against Amerul Islam Khan, C/o- Samruddin Khan, address Vill- Banagram, P.O- Chhatna, P.S- Chhatna, Dist- Bankura, Pin No-722132 for theft of electricity u/s-135(i)(a) of the electricity Act'2003 and electricity (Amendment) Act'2007 as stated here under:-

That on 08.09.2021 in between from 14:30 Hrs. to 14:55 Hrs. myself along with (i) Debraj Singha Thakur S/O-Sri Shakti Pada Singha Thakur, JE Grade-I (ii) Chintaharan Chakraborty, C/O- Lt. Tulsidas Chakraborty, Sr. TSH, (iii) Bhaduri Rajwar, C/O- Lt. Motilal Rajwar, TSH all of Chhatna C.C.C. WBSEDCL & Sitaram Banerjee, C/O- Lt. Niranjana Banerjee, Special Officer, S & LP Cell (i) Asit Chandra De, C/O- Sadhan Chandra De, DE, S & LP Cell all of Bankura Region Office WBSEDCL inspected the domestic premises of Amerul Islam Khan, C/o- Samruddin Khan as noted above and found that he was using electricity unauthorizedly and dishonestly by direct hooking from nearby LT mains of WBSEDCL by means of hooking device for their domestic use.

Thus it is evident that said Amerul Islam Khan, C/o- Samruddin Khan address Vill- Banagram, P.O- Chhatna, P.S- Chhatna, Dist- Bankura, Pin No-722132 has committed theft of electricity and liable for prosecution of u/s-135(i)(a) of the electricity Act'2003 and electricity (Amendment) Act'2007. During inspection and checking in that said premises Amerul Islam Khan, C/o- Samruddin Khan (user) was not present there.

I prepared the inspection report on the spot and assessed the loads which come to 0.250 KW. Local witnesses refused to sign in the inspection report.

I directed Chintaharan Chakraborty, C/O- Lt. Tulsidas Chakraborty, Sr. TSH to disconnect the service line from pole and they accordingly disconnect the same and I seized 01 (one) item of properties under proper seizure list.

The raiding party left the site at 15:05 Hrs. on same day (08.09.2021) after completion of inspection and checking.

You are therefore requested to please treat this written complain as FIR, start a case and arrange investigation of this case.

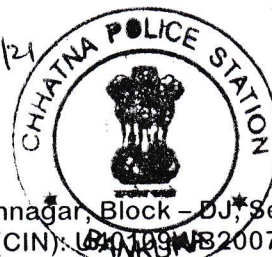
