Sir,

In producing here with the arrested person namely Babulal Hansda (37Y) S/O- Lt Sambhu Hansda of Village- Srirampur, PS- Beliatore, Dist- Bankura along with seized article 1) Two pics aluminum made Handi, 2) One Plastic pipe approx. 02 ft. 3) One aluminum plate 4) One plastic Jariken containing 19 ltrs. of ID liquor & 5) One glass bottle of 375 ml containing ID liquor, which collected from the seized Jariken as sample.

On 06.09.2021 I SI Asit Kumar Sal of Beliatore PS along with C/890 Bapi Some, C/1714 Srimanta Singha and HG 080 left from PS to perform mobile duty at PS area vide GDE no- 192 date- 06.09.2021 and CC no- 1527/21 date- 06.09.2021, as per order of O/C Beliatore PS. During my mobile duty at about 16:15 hrs, I received secret source information from my reliable source that the arrested person was manufacturing and selling ID liquor illegally in beside pond, known as 'DAS PUKUR' at Srirampur village. Accordingly, I informed O/C, Beliatore P.S. and as per direction, myself along with force, left for the house of the accd person at Srirampur village under PS- Beliatore, Dist- Bankura to work out the information.

On 06.09.2021 at about 17:05 hrs I accompanied by force reached at 'Das Pukur' at Srirampur village and found that arrested accused Babulal Hansda (37Y) S/O- Lt Sambhu Hansda of Village- Srirampur, PS- Beliatore, Dist- Bankura unlawfully manufacture ID liquor, by using various Aluminum pot (HANDI) with other accessories and stocked approx. 19 ltrs of ID liquor in a plastic Jariken. On interrogation it came to learn that the person unlawfully manufacture ID liquor and stocked it, with a view to sell and it continued since long time, I asked him to produce license or valid documents, but he failed to do. Accordingly, I arrest this person after maintaining all legal formalities of arrest and seized two pics aluminum made Handi, One Plastic pipe approx. 02 ft. One aluminum plate, one plastic Jariken containing approx. 19 ltrs of ID liquor, I arranged one glass bottle of 375 ml collected 375 ml ID liquor from the seized Jariken as sample, under proper seizure list and label, duly signed by the witnesses and the arrested person, on several requests no one public came forward to sign in the seizure list.

Under the above circumstance, I request you to start a specific case against the said Babulal Hansda (37Y) S/O- Lt Sambhu Hansda of Village- Srirampur, PS- Beliatore, Dist- Bankura and arrange for its investigation.
