In reference to the quoted above, this is to state that a group
 of Contract Casual labours of FSD - Bixma were agitating since morning
 on date at premises of FCI, District Office - Bankura by unrest-
 ing all the official force doors, blocking the main entrance, harass-
 ing employees, abusing language used against employees and
 even completely disconnecting the electricity connection of the
 office. Due to prolonged disconnection of electricity, all the works
 including vital payments has been severely hampered. Initially
 the agitation was allowed to become it in a peaceful manner
 but unfortunately at the end of the day resulting in brutal
 beaten of watch & ward staff namely: Prakash Kumar,
 Suparat Baidya & Sandipan Ghosh who have been severely
 injured & they were treated at Bankura Medical College (Copy
 enclosed for ready references), by the above mentioned Contract
 Casual labour & their allied gangs. They have initially destroyed
 our FCI property & by broken chairs they brutally beat our watch
 & ward staff. In such condition, the staff of FCI, D.O - Bankura
 especially lady officers/officials are feeling deep insecurity for
 attending the duty.

Hence, you are earnestly requested to investigate the matter
 with deep concern & take appropriate action as early as possible.
