Sub:- Prayer for lodging specific case U/S-379/411/413/414/120B IPC against one Bidhan Chandra Ghosh (27 Yrs) S/O- Gopal Ghosh of Village - Karanjora, PS+Dist- Bankura , Probodh Mondal @ Laltu S/O- Pareshnath Mondal of Vill- Barul Suripara PS- Jamuria , Paschim Bardhaman , Karim Khan S/O- Not known of Ranai , Raniganj , Paschim Bardhaman & others.

Sir,

In producing herewith one arrested accused person namely Bidhan Chandra Ghosh (27) S/O- Gopal Ghosh of Village- Karanjora, PS and District- Bankura along with two seized motor cycles of the following description :- i) Black colour Hero Passion Pro having Engine number HA10ENDHK57163, Chassis NO. MBLHA10AWDHK25939 without any number plate, and ii) Grey Colour Honda Shine having Engine Number JC36E77871552, Chassis No. ME4JC36KHD7287029 without any number plate , I beg to state that on 25.10.2021 night myself SI Shyamalendu Chowdhury along with force were performing night mobile patrolling duty in PS area as per detailment with following forces namely C/1837 Prosenjit Nayek & C/296- Shrishtidhar Juin vide Bankura PS CC No-5209/2021 dated 24.10.2021 and Bankura P.S GDE No- 1390 dt 24.10.2021. During my mobile patrolling duty at about 00.15 hours, duty officer of Bankura PS namely ASI Mahadeb Garai informed me that he has received a secret source information that one Bidhan Chandra Ghosh of Village- Karanjora , PS + Dist- Bankura is involved in dealing with stolen motor cycles ; he used to procure stolen motor cycles from the motor cycle lifters and then sell those to his customers in exchange of money. Presently some stolen motor cycles may be found in his house. I was directed to work out the Information (which was noted in Bankura PS GDE No. 1432 dated 25.10.2021. Accordingly, myself along with force held raid and search at the house of suspect Bidhan Chandra Ghosh at Vill- Karanjora, PS+Dist- Bankura & found two motor cycles in the house of said Bidhan Ch. Ghosh. On demand said Bidhan Ch. Ghosh failed to produce any document in support of the ownership of the said two motor cycles and he also disclosed after a prolonged interrogation that these motor cycles have been stolen few months ago by habitual bike lifters Probodh Mondal @ Laltu S/O- Pareshnath Mondal of Vill- Barul Suripara PS- Jamuria , Paschim Bardhaman & Karim Khan of Ranai , Raniganj , Paschim Bardhaman. Said Bidhan Ch Ghosh also

disclosed that he procured these stolen motor cycles from them and kept with him for selling those to someone else in exchange of money. Bidhan Ch. Ghosh also disclosed that he purchased huge numbers of such stolen motor cycles from motor cycles lifters and then sold those to many people of Bankura District and other districts of West Bengal in exchange of money. He made it his profession. He is doing this illegal activity since last 2 years (approx)

Accordingly, I seized two motor cycles of the following description from the possession of the suspect Bidhan Ch. Ghosh :- i) Black colour Hero Passion Pro having Engine number HA10ENDHK57163, Chassis NO. MBLHA10AWDHK25939 without any number plate, and ii) Grey Colour Honda Shine having Engine Number JC36E77871552, Chassis No. ME4JC36KHD7287029 without any number plate as there is every reason to believe that these two motor cycles are stolen from anywhere. As there was no public witness to put his signature on the seizure list as witness, the accompanied forces put their signature on seizure list as witness as they have witnessed the seizure.

I have also arrested the accused namely Bidhan Ch. Ghosh (27 Yrs) S/O- Gopal Ghosh of Karanjora, PS+Dist- Bankura for the sake of proper investigation of this case and to unearth the complete circle starting from stealing the motor cycles to their disposal.

So, I pray before you to lodge a specific case against the accused persons as noted above under proper section of law as a thorough investigation into this matter is highly required to identify and arrest all the miscreants involved in this matter and to recover all the stolen motor cycles.
