Subject: Prayer for lodging a FIR against driver and owner of the tractor without number plate having engine no. 3100DL83E735005F3 and chassis no. FZ0SG744222SM fitted with sand loaded trolley and others as per Law.

Sir,

In producing herewith seized alamat viz 1) One blue colour Sonalika DI-734 having engine no. 3100DL83E735005F3 and chassis no. FZ0SG744222SM fitted with sand loaded (approx 100 Cft) trolley, and seizure list. I, ASI Pradip Kr Mahato of Barjora P.S do hereby lodge a complaint, to the effect that today on 30/10/2021 at about 19:15 hours I received an secret information in course of mobile duty that one sand loaded tractor, coming towards Barjora side from Maliara side under Barjora P.S. Accordingly, I informed the matter to I/C Barjora P.S while he pleased to direct me to work out the information. Hence I along with accompanying force C/670 Ajit Gorai, C/1479 Taibuddin Mallick and NVF/560 Subhas Sen reached at 19:55 hours at Barjora Maliara road, near Maliara Sadarghat Bridge and found that the above noted tractor was coming from Maliara side and on seeing our police vehicle the driver parked the above noted tractor beside road and fled away towards jungle side. There is reasonable ground to believe that the loaded sand was illegally extracted by the driver and owner of the above noted tractor. I summoned the local people to be witness during search but none responded my appeal. Finding no other alternatives I conducted search in presence of accompanying force then I found no documents/ papers in support of the tractors and sand. Accordingly I seized the above noted tractor fitted with sand loaded trolley under proper seizure list duly signed by police witnesses in between 20:35 hours to 21:05 hours, as there was no public witness to sign in seizure list and collected 2 K.G sand from the seized alamat as sample collected from trolley for violating the provision of Mines and Minerals (Development and Regulation) Act.

Therefore I am praying to your good self that a specific case under proper section of law may kindly be registered against the driver and owner of the tractors without number plate having engine no. 3100DL83E735005F3 and chassis no. FZ0SG744222SM and others and arrange for its regular investigation.
