Sir,

In producing here with the arrested person namely Kanchan Roy (33Y) S/O- Shyamapada Roy of Amthiya, PS- Beliatore, Dist- Bankura along with seized four by-cycles and sand four loaded plastic cement's bags.

Today i.e. on 20.10.2021, I, SI Ramranjan Dhamatkarni of Beliatore PS along with C/1494 Rajib Kumar Singh, C/902 Malay Mondal and HG/674 Chinmay Saren as per order of O/C Beliatore PS performing mobile duty in Beliatore PS area, vide GDE no-652 date- 20.10.2021 and CC no-1861 /21 date- 20.10.2021. During my said duty at 16:45 hrs I received information from a credible local source of illegal excavation of sand by cycle from Shali river bed near Amthiya village under Chhander GP. At 17:15 hrs I rushed to the spot and found that in the leadership of arrested accused Kanchan Roy (33Y) S/O- Shyamapada Roy of Amthiya, PS- Beliatore, Dist- Bankura some other persons were illegally lifting sand from Shali river bed, they loading sand in plastic cement's bag and carry in by cycle. After seeing out Police team all were left their by-cycle and plastic cement's bag loaded sand and fled away from the river bed and after a hot chased we managed to apprehended him with the by cycle and plastic cement's bag loaded with sand.

On interrogation he stated his particulars namely Kanchan Roy (33Y) S/O- Shyamapada Roy of Amthiya, PS- Beliatore, Dist- Bankura, On demand the said person failed to produce any valid license or documents in support of his possession of the said sand in it. Accordingly I seized the above noted four by-cycle and four sand loaded plastic cement's bag and arrested him.

Under the above circumstance, I request you to start a specific case against the said Kanchan Roy (33Y) S/O- Shyamapada Roy of Amthiya, PS- Beliatore, Dist- Bankura and arrange for its investigation.
