That , at night there has been several theft occurred inside the plant which incurs pecuniary loss to the plant.

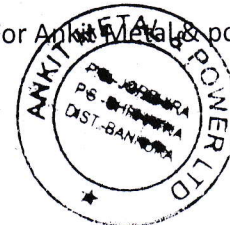
That, it is requested to take legal action against the above named person.
