

Sir,

In producing herewith the 03 (three) seized Tractor I] bearing reg. no- WB81-1864, (Blue colour Sonalika DI-734), II] Engine No- NGNL264, Chassis No- 00650543931 (Red colour Mahindra 265 DI Bhoomiputra) without number plate, and III] Engine No-NFNB00832, Chassis No- 006554... rest numbers covered by a plate (Red colour Mahindra B-275 DI Bhoomiputra) without number plate with sand loaded in trolley without any registration number along with seizure list. Today on 08.09.2021 at 20.45 hrs I received a source information regarding illegal transportation of sand through Monihara- Tulsa road under Chhatna PS and I informed the matter to I/C Chhatna PS vide Jhantipahari O.P. GDE No- 199, date - 08.09.21 and as per his direction I along with C/276 Golok Bihari Mahato and NVF/0125 Samim Akhter left from Jhantipahari O.P. vide Jhantipahari O.P. C.C No -570/21, date - 08.09.21 to work out the source information. When I along with force reached at near Garrah village, PS - Chhatna at about 21.15 hrs and found three (03) Tractors I] bearing reg. no- WB81-1864, (Blue colour Sonalika DI-734), II] Engine No- NGNL264, Chassis No- 00650543931 (Red colour Mahindra 265 DI Bhoomiputra) without number plate and III] Engine No- NFNB00832, Chassis No- 006554... rest numbers covered by a plate (Red colour Mahindra B-275 DI Bhoomiputra) without number plate sand loaded in the trolley coming from Monihara side towards Tulsa side, after seeing the Police vehicle all the driver of the above noted tractors, stopped their tractors and fled away, after a hot chase none could be apprehended. I searched the surrounding area for its owners and drivers, but none could be seen there. I waited there for a reasonable time, but none appeared there to produce any valid documents regarding their tractors as well as sand materials. On enquiry it also revealed that the said tractors being loaded with sand in trolley were seen before at Monihara- Tulsa road at several occasions. So, aforesaid 03 (three) tractors driver and owners violating the govt. order regarding suspension of transport of mining activities from 05.07.21 to 30.09.21 vide Memo No. 1031 (220) /MM/sand/2021, dated - 05.07.21 of District Magistrate, Bankura. It is crystal clear that all the driver and owners have loaded sand in their tractor by fraudulent means after stealing the same and transporting it different places for its concealment to hoard it at secret places and with a view to dealing with stealing sand from different areas and selling it to different places for their personal gains and causing huge loss to the Govt. So, I seized all the aforesaid 03 (three) Tractors I] bearing reg. no- WB81-1864, (Blue colour Sonalika DI-734), II] Engine No- NGNL264, Chassis No- 00650543931 (Red colour Mahindra 265 DI Bhoomiputra) without number plate, and III] Engine No-NFNB00832, Chassis No- 006554 rest numbers covered by a plate (Red colour Mahindra B-275 DI Bhoomiputra) without number plate with sand loaded in trolley without any registration number under proper seizure list. The sand loaded three (03) tractors has been kept at Jhantipahari O.P under Chhatna PS.

So, I pray before you to lodge a specific case against the drivers and owners of aforesaid 03 (Three) tractors, as per specific section of law.
