Sub: Apprise of the happenings of a street accident and prayer for lodging an F.I.R. in this respect.

Sir,

With due respect I would like to convey to you of the fact that I, Jogesh Chandra Singh s/o late Tarapade Singh is a permanent resident of village- Arjunpur P.O. Purandarapur PS Bankura in the district of Bankura PIN CODE- 722155. My younger brother, Goutam Chandra Singh, aged 52 was returning Arjunpur from Heavy more on 15-12-2021 riding on a bi-cycle along N.H-60. When he was on his way leads to Arjunpur Bus stop two bikes suddenly strike his bi-cycle badly from the backside of my brother at about 200m. south from Arjunpur Bus stoppage at 3:30 pm on 15-12-201. My brother was cycling ahead along his left side on the road as usual. One of the two bikes bears no. WB 40L 2223. My brother has been the victim of careless & rough driving/reckless & rash driving. The accident has caused his fore-head bone fracture, one of his cheek-bone fracture, spleen injury with internal bleeding as detected on 16-12-2021 morning, damage by uprooting one tooth from his upper jaw and limbs injured on several parts of his body with feeling of noiceptive, functional and intense pains. He has been admitted at BSMC & Hospital, Bankura vide male Surgical ward, Bed no. 38. He has been kept on observation.
