Sir,

In producing here with the arrested person namely Uttam Bauri (43y) S/O-Lt. Madan Bauri of Kamardanga, PS- Sonamukhi, Dist- Bankura along with seized 1) Approx. 19 ltrs of ID liquor in one plastic jariken, 2) One glass bottle of 375 ml containing ID liquor, (which collected from the seized Jariken No 1. 3) approx. 05 ltrs of ID liquor in one plastic Jariken, 4) One glass bottle of 375 ml containing ID liquor, (which collected from the seized Jariken No2.& 5) One old By- Cycle.

On 25.12.2021 I SI Asit Kumar Sal of Beliatore PS along with C/890 Bapi Some, C/ 1588 Rajib Panda, HG/54 Amit Narayan Deb left from PS to perform mobile duty at PS area vide GDE no- 876 date- 24.12.2021 and CC no- 2252/21 date- 24.12.2021, as per order of O/C Beliatore PS. During my mobile duty on 25.12.21 at 06:15 hrs, I received secret source information from my reliable source that the arrested persons selling illegal ID liquor at Harekrishnapur. Accordingly, I informed O/C, Beliatore P.S. and as per direction, myself along with force, left for said place to work out the information.

On 25.12.2021 at about 07:05 hrs I accompanied force reached at Harekrishnapur and found that said arrested person was selling ID liquor illegally in jungle side, after seeing police party he tried to run away, but we managed to detained him and after detained I found that he has with him 1) Approx. 19 ltrs of ID liquor in one plastic jariken, 2) approx. 05 ltrs of ID liquor in one plastic Jariken, 3) One old By- Cycle. On interrogation it could be learnt that he used to sell ID liquor's since long. I asked to produce for any valid documents in respect of stock or selling of this ID liquor, but he was unable to show any permission, or any valid documents. Accordingly, I seized 1) Approx. 19 ltrs of ID liquor in one plastic Jariken, 2) One glass bottle of 375 ml containing ID liquor, (which collected from the seized Jariken No-1) 3) approx. 05 ltrs of ID liquor in one plastic Jariken, 4) One glass bottle of 375 ml containing ID liquor, (which collected from the seized Jariken No- 3) & 5) One old By- Cycle, under proper seizure list and labeled duly singed by the witnesses and the accused Person. During seizure I also collected sample from those seized articles under proper seizure list and label. During process of seizure the available local people refused to signed in the seizure list. After that I arrested him after maintain all legal formalities of arrest and maintained all guide line of NHRC.


