
In producing herewith seized article i.e. (1) 02 (two) plastic made 05(five) litters container loaded with approx 05(five) litters each liquid appearing to have been illicit liquor after collecting sample in a (2) 02 (two) 600 ML plastic bottle loaded with approx 550 ml liquid from both container .(3) Some plastic glass & (4) one funnel from the premises of Dulali Murmu I, do hereby submit complaint against accused Dulali Murmu (56years) w/O Madan Murmu of Vill -Benadoba P.O + P.S - Simlapal, Dist. Bankura to the effect that on 19.03.2022 at 12.15 hrs received source information that one Dulali Murmu (56years) W/O Madan Murmu of vill -Benadoba P.O + P.S - Simlapal has been selling illicit I/D liquor at her house premises. I, SI Biswajit Mukherjee along with force & local village police held raid there i.e Benadoba house of above noted Dulali Murmu at about 12.55hrs and found that she was selling illicit liquor in a polithin glass from plastic container. On seeing police party she fled away and managed to conceal himself behind a bush. The raid team found I/D liquor and other related articles in the house premises of Dulali Murmu which was possessed and getting sold illegally. So, I seized the following articles in between 13.25.hrs to 14.15 hrs (1) 02 (two) plastic made 05(five) litters container loaded with approx 05(five) litters each liquid appearing to have been illicit liquor after collecting sample in a (2) 02 (two) 600 ML plastic bottle loaded with approx 550 ml liquid from both container. (3) Some plastic glass & (4) one funnel from the premises of above noted Dulali Murmu under proper seizure list as alamat.

So, I pray before you to start a case under proper section of law against accused Dulali Murmu (56years) W/O Madan Murmu of Vill -Benadoba P.O + P.S - Simlapal, Dist. Bankura and arrange for its investigation.
