Sir,

In producing here with arrested accused person namely Rasik Hembram 27 Yrs S/O Lt. Gopal Hembram of Vill Simla(Amdiha), P.S.-Khatra District- Bankura along with seized articles under seizure list viz. i) One jerkin containing 20 ltr. Illicitly distilled (ID) liquor Marked as exhibit 'A' in which 100ml Illicitly distilled has been taken in a bottle as sample as marked as exhibit -'B'. To the effect that today evening on 26.07.22 a Special Drive against ID liquor was held under Dhanara GP vide GDE no. 1078 dt. 26.07.22 & CC no. 1218 dt. 26.07.22 . During raid on received of credible information myself along with force had been in the house of Rasik Hembram , on seeing the police personnel two person were fled away, then we found the above noted seized articles was kept in his house baranda for selling . Accordingly I interrupted the above noted accused person and seized the articles as per seizure list. In course of interrogation the above noted accused disclosed his identity as noted above and also admitted that, he purchased the ID liquor for selling with a view to high price and he failed to produce any valid documents in respect of the seized articles , as such it is reason to believe that the accused person import the said ID liquor for selling illegally and it is illegal intoxicant other than spirit or intoxicating drug . Accordingly I seized the above articles in presence of witness and taken sample from Marked-'A' . Seized in between 19.15 to 19.45 hrs . I arrested the accused Rasik Hembram on the charge of section 46 BE Act.

During enquiry it is fact that the ID liquor is basically manufactured with a un scientific way or unauthorized manner causing it may be danger of human consumption.

Under the fact and circumstances, I pray a specific case may be recorded against the arrested accused person Rasik Hembram 27 Yrs S/O Lt. Gopal Hembram of Vill Simla(Amdiha), P.S.-Khatra District- Bankura under proper section of law and arranged please investigation.
