In producing herewith seized article i.e. (1) 01(one) plastic made 10(ten) litters container loaded with approx 09(nine) litters liquid each containers appearing to have been illicit liquor after collecting sample in a (2) 01 (one) 600 ML plastic bottle loaded with approx 550 ml liquid from the seized container. (3) Some plastic glass & (4) one funnel from the premises of Patit Tudu. I, do hereby submit complaint against accused Patit Tudu(30) S/O Lt Laxmikanta Tudu of vill Arraha P.O -Bhutsahar, Dist. Bankura to the effect that On 10.06.2022 at 18.05 hrs received a source information that one Patit Tudu(30) S/O Lt Laxmikanta Tudu of vill Arraha P.O -Bhutsahar, P.S Simlapal has been selling illicit I/D liquor at his house premises. I, SI Biswajit Mukherjee along with force & local village Police held raid there i.e Arraha house of above noted Patit Tudu at about 18.05 hrs and found that he was selling illicit liquor in a polithin glass from plastic container. On seeing Police party he fled away and managed to conceal himself behind a bush. The raid team found I/D liquor and other related articles in the house premises of above noted Patit Tudu which was possessed and getting sold illegally. So I seized the following articles in between 18.25.hrs to 19.15 hrs (1) 01(one) plastic made 10(ten) litters container loaded with approx 09(nine) litters liquid each containers appearing to have been illicit liquor after collecting sample in a (2) 01 (one) 600 ML plastic bottle loaded with approx 550 ml liquid from the seized container. (3) Some plastic glass & (4) one funnel from the premises of above noted Patit Tudu under proper seizure list as alamat.

So, I pray before you to start a case under proper section of law against accused Patit Tudu(30) S/O Lt Laxmikanta Tudu of vill Arraha P.O -Bhutsahar P.S Simlapal, Dist. Bankura and arrange for its investigation.
