In producing herewith seized article i.e. (1) 02 (two) plastic made 05(five) liters container loaded with approx 05(five) liters each liquid appearing to have been illicit liquor after collecting sample in a (2) 02 (two) 600 ML plastic bottle loaded with approx 550 ml liquid from both container .(3) Some plastic glass & (4) one funnel from the premises of Rabi Saren (44years) S/O Lt.Saban Saren of vill.- Badageria Adibasipara, P.O-Pathardoba, P.S- Simlapal, Dist.- Bankura to the effect that on 26.07.2022 at about 11.05 hrs. I, held raid at Badageria Adibasipara village in the house of the above noted Rabi Saren and found that he was selling illicit liquor in a polithin glass from plastic container. On seeing the police party he fled away and managed to conceal himself behind a bush. The raid team found I/D liquor and other related articles in the house premises of Rabi Saren which were possessed and getting sold illegally. So complainant seized the following articles in between 11.35.hrs to 12.25 hrs (1) 02 (two) plastic made 05(five) liters container loaded with approx 05(five) liters each liquid appearing to have been illicit liquor after collecting sample in a (2) 02 (two) 600 ML plastic bottle loaded with approx 550 ml liquid from both container .(3) Some plastic glass & (4) one funnel from the premises of above noted Rabi Saren under proper seizure list as alamat.
