**Sub:-**Prayer for lodging FIR against offending driver of the offending lorry bearing Regn. no- WB23E/9717.

Sir,

In producing herewith one detained offending lorry bearing Regn. no- WB23E/9717. I, do hereby submit complaint against driver of the offending lorry bearing Regn. no- WB23E/9717 to the effect that on 05.09.2022 I SI Joydev Gorai along with force C/-779 Swapan Hazra, C/-1736 Anil Hansda HG/-21 Tapas Sarder vide CC No-2414/22, 17:45hrs dt-05.09.2022 was performing night patrolling duty. During patrolling duty we reached Bikrampur more under Simlapal PS and stationed beside the road. At about 23:55 hrs one lorry bearing Regn. no- WB23E/9717 coming from Raipur side being driver rashly & negligently dashed the on duty constable-779 Swapan Hazra standing beside the SH-9 signaling to slow down & move. The offending driver took for the offending vehicle bearing Regn. no- WB23E/9717 from the spot and parked it at the road side near PNB bank Bikrampur and fled away. As a result constable-779 Swapan Hazra fell down on road side and he received bleeding head injury. I along with force arranged to shift him to Simlapal BPHC from where he was referred to BSMCH Hospital Bankura. I detained the said offending vehicle loaded with Sponge Iron and kept it at Simlapal PS compound.

So, I pray before you to start a case under specific section of law against the driver of the offending lorry bearing Regn. no- WB23E/9717 and arrange for its investigation.
