Sub:- Prayer for lodging F.I.R under proper section of law.

Respected Sir,

In producing herewith one (01) tractor having bearing no- Tractor bearing no- WB-55B/3171 and Eng. No-NLL2EMJ0116, Chassis no- MBNABAEXKLJL02155, MODEL No- B275 DI TU MKM DLX style as Mahindra, with red colour trolley loaded with sand under proper seizure list duly signed by the witnesses. I beg to inform you that on 07.02.2023 at about 16.05 hrs I received an information from reliable source in course of P.S mobile duty (Hirbandh PS GDE No- 254 dtd. 07.02.23 & Hirbandh P.S C.C No- 324/23 dtd. 07.02.23), that a sand loaded tractor having bearing no- WB-55B/3171 style as Mahindra, with red colour trolley which is involved in illegal sand transportation without having any proper challan or valid document is coming from Gopalpur village side towards Saluipahari village side. I informed the matter accordingly and as per order of OC Hirbandh P.S, I along with force went towards Gopalpur under Hirbandh P.S to intercept the sand loaded tractor. At about 16:45 hrs, we found that the above noted tractor having bearing no- WB-55B/3171 style as Mahindra, with red colour trolley loaded with sand was coming from Gopalpur village side towards Saluipahari village side. Seeing the Police van from a distance, the driver of the said tractor stopped vehicle by the side of road near Batirkora village and started to flee away leaving behind his vehicle on the road. I along with my accompanying force chased him and somehow could apprehend the driver of the said Tractor.

On being asked, he disclosed his identity as namely Senapati Baskey (33) S/o- Lt. Dubraj Baskey of Patharkata, PS- Puncha, Dist- Purulia. On further interrogation, I came to learn that the tractor was loaded from Kendadihi Ghat, under Puncha PS under Purulia district. On demand, he could not produce any challan or valid documents or could give any satisfactory answer in respect of his Sand loaded in Tractor.

On being search I could not find any papers of the said vehicle over the sand transportation. It is crystal clear that he has loaded sand in his vehicle by any fraudulent means after stealing it from any sand stock point. So, I seized the said vehicle with trolley loaded with sand as per seizure list and arrested the accused driver after maintaining all legal formality of NHRC guidelines of the apex court.

Hence, I pray that a specific case may kindly be started in against him and to take necessary action as per law.
