Today one person named Krishna Chandra Mahato came to the branch with one Lok Adalat notice of his wife Niyati Mahato for discussion. In conversation with him he got tempered and attacked me when I was sitting in my chair. He used slang languages and threatened me to be murdered. He also asulted me. For your proof CCTV footage are there.

The above incident occur around 11:30 PM on 03.02.2023 at branch premises.

In this regard I request you to take some lawful action against him.
