Dear Sir,

In producing herewith the following article 1. one no. two core PVC Cable of approximate length 05 meter with Hooking arrangements seized under proper seizure list, duly signed by the available witnesses I, Mr. Shouvik Malik (26 yrs), S/O- Mr. Bikash Malik, Assistant Engineer (E) & Station Manager, Sarenga Customer Care Centre, WBSEDCL, Sarenga, Bankura do hereby lodge complaint against Sri SUGAM MANDAL, C/O- MIHIR CHANDRA MANDAL, Vill-Debagram, PO-Choutar, PS- SARENGA, Dist- BANKURA-722150 today (i.e on 01.02.2023) acting on a tip-off, myself along with, Sri. Khokon Murmu, S/O- Debsaran Murmu, JE GR1 & Koushik Mahato, S/O- Sisir Mahato, SR. TSH of Sarenga CCC, WBSEDCL went to the located near Debagram village to work out on one source information that Sri SUGAM MANDAL, C/O- MIHIR CHANDRA MANDAL is consuming electricity unauthorizedly at his commercial premise. Around 4:00 PM of 01/02/2023 we reached at the premises located near Debagram village and started inspecting the poles and electric lines situated near the above mentioned location. After reaching at the location we found that Sri SUGAM MANDAL, C/O- MIHIR CHANDRA MANDAL was not present there and also not signed inspection sheet and seizer list on the spot. They identified the premises and related connections and accordingly we started inspection. During inspection the user Sri SUGAM MANDAL, C/O- MIHIR CHANDRA MANDAL found stealing electricity dishonestly by direct hooking from nearest LT Over Head line of WBSEDCL for commercial purpose and has caused financial loss to WBSEDCL. The load is assessed to be 400 watt during preparing inspection report at the spot.

Thus the user Sri SUGAM MANDAL, C/O- MIHIR CHANDRA MANDAL has violated the rules and provision of section 135(1)(a) of The Electricity Act 2003 (Amendment 2007).

Hence I seized the above noted article under proper seizure list duly signed by the available witnesses following disconnection of the unauthorized connection by removing the cables and hooking devices and producing before you with a request to initiate a cause u/s 135(1) (a) of The Electricity Act 2003 (Amendment 2007) against Sri SUGAM MANDAL, C/O- MIHIR CHANDRA MANDAL, Vill-Debagram, PO-Choutar, PS- SARENGA, Dist- BANKURA-722150 and arrange for its investigation. It is also to be mentioned that some local villagers were present there. It is also to be mentioned that we disconnected the unauthorized connection and left the premise at about 4:15 PM on the same day.
