Sir,
In producing herewith with the arrested accused person namely Sunil Khetrapal (60y) S/O- Lt Genupada Khetrapal of Baruipara, Sonamukhi, Ward no- 03, PS- Sonamukhi, Dist- Bankura along with seized articles as per seizure list. I beg to submit that in course of my spl. Mobile duty at Beliatore PS area Beliatore PS GDE No. 234 dtd. 06.03.2023 and CC NO- 564 Date- 06.03.2023 at 18.45 hrs received a secret information from my source that, one Sunil Khetrapal (60y) S/O- Lt Genupada Khetrapal of Baruipara, Sonamukhi, Ward no- 03, PS- Sonamukhi, Dist- Bankura is illegally carrying Id liquor and moving towards Brindabonpur more under Beliatore PS in his by-cycle. Accordingly I shared the information to O/C Beliatore PS and as per his direction myself along with C/619 Bikash Mondal, C/1588 Rajib Panda and NVF/324 Biplab Dey rushed to Shyam Bazar to work out the information.

After arriving there at about 18.55 hrs. I found a person coming towards Sonamukhi side riding his by-cycle carrying a bag in his by-cycle, I stopped him and asked his name, he identified himself as Sunil Khetrapal (60y) S/O- Lt Genupada Khetrapal of Baruipara, Sonamukhi, Ward no- 03, PS- Sonamukhi, Dist- Bankura, and on searching the bag I found a Jarricane containing approx 20 Ltrs of I.D Liquour. There after I asked him to produce any valid document in respect of carrying such Id liquor but he failed to produce any valid document or to give any proper explanation.

Accordingly, I seized the said articles and also seized his by-cycle under proper seizure list followed by proper sealing & labeling duly signed by the witnesses and accused person. As the said Sunil Khetrapal (60y) S/O- Lt Genupada Khetrapal of Baruipara, Sonamukhi, Ward no- 03, PS- Sonamukhi, Dist- Bankura has committed an offence under Bengal Excise Act 1909. So, I arrested him under proper memo of arrest after maintaining all sorts of norms and guidelines as per Hon'ble Apex court regarding arrest.

Therefore, I pray that a specific case may kindly be initiated against accused Sunil Khetrapal (60y) S/O- Lt Genupada Khetrapal of Baruipara, Sonamukhi, Ward no- 03, PS- Sonamukhi, Dist- Bankura under proper section of law.
