Accordingly, I seized the said articles and also seized his by-cycle under proper seizure list followed by proper sealing & labeling duly signed by the witnesses and accused person. As the said Sunil Khetrapal (60y) S/O- Lt Genupada Khetrapal of Baruipara, Sonamukhi, Ward no- 03, PS- Sonamukhi, Dist- Bankura has committed an offence under Bengal Excise Act 1909. So, I arrested him under proper memo of arrest after maintaining all sorts of norms and guidelines as per Hon'ble Apex court regarding arrest.

Therefore, I pray that a specific case may kindly be initiated against accused Sunil Khetrapal (60y) S/O- Lt Genupada Khetrapal of Baruipara, Sonamukhi, Ward no- 03, PS-Sonamukhi, Dist- Bankura under proper section of law.
