Sir/Madam,

With due respect I beg to submit that today (i.e. on 06.03.2022) at about 19.05 hrs in course of anti crime evening mobile duty myself along with force C/1070 Labsen Gorai, LC/956 Salema Khatun and NVF-0070 Bibhisan Hembram all of Hirbandh P.S Dist-Bankura, I received a source information that one Binod Mandi (42Yrs) S/O- Chand Mandi Vill-Bhubandihi, P.O-Hatirampur, PS-Hirbandh Dist-Bankura is illegally carrying Id liquor and moving towards Hatirampur more from Bhubandihi in his by-cycle. After receiving the above information I inform the matter to O.C Hirbandh PS. As per her direction we rush to the spot for workout the information. I along with force reached near Bhubandihi village at about 19.15 hrs by Govt. vehicle and found that one person coming towards Hatirampur side riding his by-cycle carrying 02 plastic bag backside of his by-cycle. I tried to stop him. Seeing the police force and police vehicle the accused person fled away from the spot and left his cycle along with 02 bag containing ID liquor. We tried our best to apprehend him but he took entry in a darkness bush, so we could not arrest him. I also seized the following articles under proper seizure list duly signed witnesses. After that I prepared label the seized articles duly signed by witnesses and taken 01 (One) bottle as sample and also collected 500 ml ID liquor in a bottle from the jarkin as sample. I made a local enquiry and it could be learnt that the above noted person is illegally selling country spirit and ID liquor without any valid license in his residential house at Bhubandihi village.

Therefore I do here by lodged a suomoto complaint against accd persons namely Binod Mandi (42Yrs) S/O- Chand Mandi Vill-Bhubandihi, P.O-Hatirampur, PS-Hirbandh Dist-Bankura to start a case U/S-46A of B.E. Act. and there by obliged.

- (2) One white plastic jarkin containing 20 ltrs of ID liquor.
- (3) Two plastic bag.
