I beg to lodge complaint that today on 23.04.2023 at 00:05 hrs., SI Ramranjan Dhamatkarni received an information from my source that 25 /30 persons were gathered near Chanduria primary school under Beliatore PS, who made a temporary tenth by bamboo and tripal with electric facilities behind the primary school and running game (Jhandi) In this temporary shed with the help of DABBA, GUTI and POT for the purpose of wrongful gain to one and wrongful loss to another. Accordingly, I informed to my O/C and per his direction myself along with ASI Dilip Kumar Singha Roy C/1768 Kishan Middya , C/1595 Ganesh Ch Mahanta, C/1588 Rajib Panda, C/206 Ramen Ch Mahata, NVF/0067 Gouranga Mondal and NVF 209 Moniram Mudi eft for Chanduria village to work out the information. After reached to the place with Govt. Vehicle and found some persons were gathered and playing Jhandi. On seeing the police party some of them who gathered there fled away taking the advantage of dark ness. But we are able to apprehend the above noted persons with the help of my accompany force. On being asked the above noted accused person failed to give satisfactory answer and unable to produce any valid documents in respect of the said game. Hence, I seized - 1) Five pieces different size of Dabba (box) made by Leather & Rexene. 2) Three set dice (GUTI) made by plastic, total 18 pics, 3) Pot two pieces made by plastic 4) One plastic ground sheet, 5) Cash RS- 22,920/- (twenty-two thousand nine hundred and twenty only), 6) One Bolero car bearing registration no- WB38S/0765 from the gambling board in presence of the above noted accused persons after preparing seizure ling duly signed by the witnesses and accused persons. After that I arrested the above noted accused persons after maintaining all the legal formalities regarding arrest and issued them arrest memo.

Therefore, I pray before you to start a specific case against the above noted accused persons under proper section of law and arranged for its investigation.
