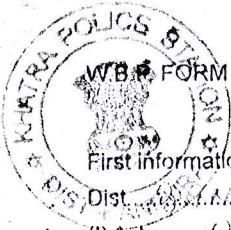

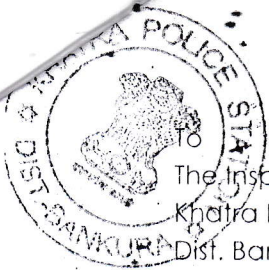

Sub:- Prayer for lodging a case against the arrested accused persons namely (1) Sudharani Soren (35 Years) W/O Ranjit Soren, (2) Rani Hansda (40 Years) W/O Bablu Hansda and (3) Sefali Soren (37 Years) W/O Mahadeb Soren all of Vill.- Burisahar, P.S.- Khatra , Dist.- Bankura for unauthorized carrying & selling of Id liquor.

Sir,

In producing here with the arrested accused persons namely (1) Sudharani Soren (35 Years) W/O Ranjit Soren, (2) Rani Hansda (40 Years) W/O Bablu Hansda and (3) Sefali Soren (37 Years) W/O Mahadeb Soren all of Vill.- Burisahar, P.S.- Khatra , Dist.- Bankura along with seized 03 (three) pieces of robber tube containing (approx) 30 Liters of I.D. Liquor under proper seizure list, I S.I. Debasis Roy of Khatra P.S. do here by lodge a complaint against said the arrested accused persons to the effect that on 30/03/23 at about 05.55 hrs I received an information that three women were coming towards Khatra from Burisahar and they were carrying ID liquor. After receiving this information, myself along with PSI Iswar Soren, LC/1880 Purnima Murmu, LC/1653 Krishna Mandal left for Burisahar at about 6.20 hrs, I along with officers and force reached there and found that three women were standing at Burisahar and they were carrying three tubes. On being asked they disclosed their identity as (1) Sudharani Soren (2) Rani Hansda (3) Sefali Soren. On interrogation they further stated that they were carrying 30 Ltrs(approx) ID liquor in three robber tubes. They further informed that in each tube there is approximately 10 Ltr. ID liquor. They failed to produce any valid documents in support of their possession of ID liquor. Then I seized those recovered ID liquor under proper seizure list. I arrested those three women for carrying ID liquor.

Therefore I pray that a specific case may kindly be started against arrested three women namely (1) Sudharani Soren (35 Years) W/O Ranjit Soren, (2) Rani Hansda (40 Years) W/O Bablu Hansda and (3) Sefali Soren (37 Years) W/O Mahadeb Soren all of Vill.- Burisahar, P.S.- Khatra , Dist.- Bankura
