Sub: Complaint for lodging a FIR.

Sir,

With due respect and humble submission I beg to state that, I, SI Himadri Sekhar Giri of Sarenga P.S. do hereby lodged a complaint against 40-50 unknown supporters of Kurmi Samaj, Paschim Banga and Purbanchal Adibasi Kurmi Samaj to the effect that, on 20th April 2023 the Ghaghar Ghera Central Committee Khemasull, Paschim Medinipur, pin no-721513 issued a press release for 12 hours Hurka Jam/Bandh at Jungle Mahal, West Bengal on 26.04.2023 from 06 AM to 06 PM with a demand for inclusion of Kurmi Community people in ST list. I was detail for duty in c/w the said Bandh vide Sarenga PS GDE No-1191 Dated-26.04.2023 and Sarenga PS Special CC No-121/23 Dated-26.04.2023. I found that, 20-25 supporters of Kurmi Samaj, Paschim Banga have blocked SH-4 at Karbhanga under Bikrampur GP from 06:02 hrs and 20-25 supporters of Purbanchal Adibasi Kurmi Samaj have blocked SH-9 at P. More under Neturpur GP from 06:50 hrs. As a result huge number of vehicles got stack on the road, causing harassment of passenger buses, small vehicles and also public carrier. I requested them several times to withdraw the road blockade to allow normal movement of traffic. But they did not pay any response and disobeyed my order. On the contrary they started slogans against the State Government over different issues by using microphone without permission from the appropriate authority and used filthy languages. They created an unlawful assembly in both places and disobeyed the order to withdraw road blockade, causing harassment to innocent peace loving people and wrongfully restrained the passengers of vehicle for their normal movement.

So, I pray that, a FIR may kindly be lodged against the 40-50 unknown supporters of Adibasi Kurmi Community for making unlawful assembly, disobeying the order of public servant, in discharge of public function and also harassment to innocent peace loving people and wrongfully restrained the passengers of vehicle and also obstructing the Highway of West Bengal.
