Sub: Prayer for lodging FIR.

Sir.

In producing herewith arrested accused person namely Gurupada Dhara (42 yrs) S/o-Lt. Dolgobinda Dhara of Vill-Brahmandiha, PS-Sarenga, Dist-Bankura along with seized 25 Ltrs ID liquor under proper seizure list duly signed by the witnesses. I, ASI Rakesh Ghosal of Sarenga P.S do here by lodged a complaint against him. I beg to state that, today on 27.04.2023 at 18:05 hrs I along with C/338 Bishnupada Hansda & NVF/0712 Munna Mitra was engaged in special mobile duty at PS area vide Sarenga PS GDE No-1261 dtd. 27.04.2023 & Sarenga P.S. CC No- 1332/23 dtd. 27.04.2023. During mobile duty received a credible source information that, near Nadighat More under Brahmandiha village, Gargaria GP the above noted person was selling ID liquor illegally to the customers in exchange of money. Accordingly I informed the matter to I/C Sarenga PS and as per his direction myself along with force arrived at Brahmnadiha village and kept our Govt. vehicle at a reasonable distance to work out the information and moved towards the straw shaded (Hut)room as shown by the source . We surrounded the room found he was selling ID liquor to the customers, seeing the police party the persons who were consuming liquor managed to flee away but we apprehended him who was selling ID liquor. We searched the straw shaded (Hut) room thoroughly and found approx 25 Ltrs ID liquor kept in 02 plastic jaricane, value of Rs-25 X 40=1000(Approx). I asked him regarding any valid document or license for stocking such ID liquor and selling the same to the customers but he failed to produce any valid document in this respect. Accordingly I seized the same under proper seizure list and labeled duly signed by the witnesses. On interrogation he disclosed his identity as Gurupada Dhara (42 yrs) S/o-Lt. Dolgobinda Dhara of Vill-Brahmandiha, PS-Sarenga, Dist-Bankura and he also stated that, he was a FIR named accused person in c/w Sarenga P.S. Case No-07/22 Dated- 11.01.22 u/s-46A(c) B.E. Act and he was arrested on 11.01.2022.

As he possessed and was selling ID liquor by violating the provision of Bengal Excise Act, hence t arrested the aforesaid person Gurupada Dhara (42 yrs) S/o-Lt. Dolgobinda Dhara of Vill-Brahmandiha, PS-Sarenga, Dist-Bankura after maintaining all legal formalities regarding

Under the above circumstances, I pray a case may kindly be registered against him under proper section of law, as he possessed and was selling ID liquor by violating the
