Sub- Prayer for lodging FIR.

Sir,

In producing here with the one tractor (blue colour Sonalika DI 47 Dx) vide bearing registration no- WB68Z/0398 fitted with sand loaded trolley approx. 50 cft.

The fact of the case in brief is that on 27.05.2023 myself along with force C/108 Swdeshranjan Patra, C/1595 Ganesh Mahanta and NVF-288 Ashis Kr Mahata were performing mobile duty at Beliatore PS area, vide GDE No-1098 Date- 27.05.2023 and CC no- 1243/23 date- 27.05.2023. During my duty at 23:35 hrs I received information from a credible source of illegal transportation of sand by tractor near Amthiya village under Chhandar GP. To work out the source information on 28.05.2023 at 00:05 hrs myself along with force rushed to Amthiya village and found one tractor bearing registration no- WB68Z/0398 is coming from Amthiya village side. But observing us from a certain distance the driver stop the vehicle and flew away from that place leaving the tractor fitted with sand loaded trolley. I along with force chased behind him but he managed to escape. On enquiry it also came to light that the driver of the vehicle in connivance with the owner of the tractor procured the sand either by committing theft or by any fraudulent means for selling the same in the locality without paying any revenue to the Govt.

Accordingly, I seized the tractor (blue colour Sonalika DI 47 Dx) vide bearing registration no- WB68Z/0398 fitted with sand loaded trolley approx. 50 cft under proper seizure list duly signed by the police witnesses.

Under the above noted facts and circumstances, you are requested to start a specific case against the driver and owner of the seized tractor under proper section of law and arrange for its investigation.
