Sub- Prayer for lodge a Specific Case.

Sir,

In producing herewith the accused person namely Kartick Murmu (43) S/o Lt. Ramesh Murmu of Dhanara, PS Khatra , Dist- Bankura, under arrest along with seized articles i.e A 6 pieces of Jam trees logs having (i) length approx 7 Ft, Diameter – approx 04 Ft, (ii) length approx. 7 ft. Diameter approx. 3 Ft., (iii) length approx. 6.6 Ft. Diameter approx. 3.6Ft,(iv) length approx. 7 Ft. Diameter approx. 2.6, (v) length approx. 4Ft, diameter 3 Ft, (vi) length 7 Ft. diameter 3 Ft. Three wooden logs of Akashmoni trees having length approx. (i) 4 Ft. diameter 3.6Ft. (ii) length approx. 3 Ft., diameter 3 Ft, (iii) length approx. 7 ft. diameter approx. 2.6 and a Tractor having Reg. no. WB 68AD/9038 along with a trolley without number plate, I beg to state that today on 03.05.23, I along with C/1651 Bapi Rajak, C/425 Muktaram Mandal, NVF0271 Rajib Paramanik was performing RT mobile duty which refers to Khatra PS GDE no- 108 Dt- 03.05.23 and CC no- 919/23 Dt. 03.05.23. During my mobile duty at about 14.45hrs while myself along with force was going towards Kashipur via Dumrikol, at Dumrikol village I found that one Tractor having Regd. No- WB 68AD/9038 was coming from Kashipur side loaded with wooden loges. On suspicion, I stopped the tractor along with trolley. On being asked the driver of the tractor disclosed identity as Kartick Murmu (43) S/o Lt. Ramesh Murmu of Dhanara, PS Khatra, Dist Bankura. On demand he failed to produce any valid documents in supports of carrying wooden logs and on being asked he also confessed that he collected those wooden loges from the jungle of Dumrikol. He further confessed that the trees were illegally cut down at the jungle by some persons and they also loaded those wooden logs at the trolley. Then I seized those wooden logs as mentioned above along with above mentioned tractor and trolley under proper seizure list. The seizure was done from 15.05hrs to 15.55hrs. I arrested Kartick Murmu (43) S/o Lt. Ramesh Murmu of Dhanara, PS Khatra, Dist Bankura for stealing tress from jungle.

Under the fact and circumstances I pray that specific case may be recorded against the arrested accused person namely Kartick Murmu (43) S/o Lt. Ramesh Murmu of Dhanara, PS Khatra, Dist Bankura U/S 379/411/34 IPC and 33 of the Indian Forest Act and arrange for investigation.
