In producing here with the accused 1) Kalyan Majhi (55yrs), S/o-Lt Sanatan Majhi of vill-Mourai , PS-Indas, Dist-Bankura, 2) Sajal Das@Tapas (28yrs), S/o- Jadab Das of vill- Bhagabanbati, PS-Indas, Dist-Bankura, 3) Biswajit Majhi (38yrs), S/o- Lt Shibu Majhi of vill-Amrul, PS-Indas, Dist-Bankura along with seized 20 (Twenty) pcs Bomb under proper seizure list. I, ASI Debabrata Mukherjee do here by lodge the complaint against the above three arrested persons and others to the effect that today 14.06.23 at about 08:00hrs when I along with C/31 Bishnupada Santra, HG Krishna Kumbhakar was performing vehicle checking duty near Bandherpar bazaar more under Indas PS, then at about 08:45 hrs we saw a bolero car bearing registration No WB 38T 7283 was coming from the side of Samroghat in high speed. On suspicion we somehow managed to stop the car. The driver of the car jumped out of the car and fled away. The other co passengers were also tried to escape from the spot. But we somehow managed to apprehend the above noted accused persons but the other three to four persons managed to escape from the place. Then I started to interrogate the three apprehend persons on interrogation they confessed that they are carrying 20 (twenty) Pcs of live bombs in a bag in the car with a view to burst the same for creating panic among the public. I asked to produce any valid document regarding the possession and carrying of the bombs. But the fail to produce any valid documents.

Under the above noted circumstances I request you to start a case under proper section of law.
