I SI Somnath Pal OC Indas PS submit complaint as suo-moto against i) Bhola Dutta of Saspur, ii) Dilip Roy of Saspur, iii) Ganesh Das of vill- Narrah iv) Anita Hati of Akui all of PS- Indas, Dist- Bankura and 100-150 persons that, nomination of Panchayat Election started on 09.06.2023 at BDO Office Indas. To conduct smooth and peaceful nomination, force have been deployed at different locations to promulgate order u/s 144 Cr.P.C as passed by SDO Bishnupur vide Memo No- 656(57)-SEC/3L-12/2023 dtd-11.06.23 of Sub-Divisional Magistrate, Bishnupur Bankura w.e.f 12.06.2023 20.06.2023 in between 10:00 hrs and 17:00 hrs. Accordingly I detailed officer and force vide CC No- 2160/23, 2162/23, 2163/23 dtd- 14.06.2023 surrounding Nomination Centre with in one KM of periphery. Having drop gate at Pirtala & Hospital More, In front of Nomination Centre to ensure promulgation of 144 CrPC in letter in sprit for smooth Nomination process. Today 14.06.2023 nomination programme started at Indas BDO Office from 11:00 hrs and force was deployed in due time i.e. 08:00 hrs. At about 12:05 hrs supporters of BJP Party more than 300 numbers being equipped with bamboo sticks, rods started shouting their slogans and started to move towards the drop gate from the side of Saspur to Indas Pirtala. Considering the situation I requested all of the supporters through Public Address System (PAS) not to gather in more than 05 numbers and obey the condition of 144 CrPC as the 144 CrPC already promulgated at the area.

However even repeated request those person did not pay any heed our caution rather they came forward aggressively towards us.

It is also noted here that as per guidelines of West Bengal Election Commission we allowed the candidates with their proposer to go at Nomination Centre individually. Accordingly we allowed so many candidates to submit their nomination today also i,e on 14.06.2023.

The area is densely market area. There are so many small shops. To ensure safety and security of the public and to ensure the lawful duty of on duty police personnel, I declared loudly that assembly as unlawful assembly and requested them to disperse the area and assist police to discharge their

lawful duty. But the assembly did not bother to pay heed to our lawful words despite repeated requested. That unruly mob started pelting stone and brick beating aiming to police personnel on duty and started to ransacked guard rail drop gate etc. Suddenly mob attacked upon police personnel on duty and tried to overpower us.

I immediately inform duty officer SI Bidyapati Kar to inform all Superior Officer for ensuring re-enforcement. Then I again loudly announce addressing to unlawful mob to vacate the place and assist police authority to maintain law and order of the area and promulgate order of the Ld. Executive Magistrate. In the meantime SDPO Bishnupur, CI Sonamukhi reinforced at the spot and they also tried to convince unlawful mob to vacate the place and assist police authority to maintain law and order of the area and promulgate order of the Ld. Executive Magistrate.

But on repeated request they did not pay any heed. At that time, it will be around 12:25 hrs some member of unruly mob again started to damage public property and shop of the bazaar and started again brick batting aiming to on duty police personnel. At this situation police cannot sit idly by.

Finding no other alternatives to ensure safety security of the general people of the Indas Bazar area, shop keepers and police personnel on duty, to protect public property we resorted to mild force to disperse the unruly mob. Then chased the mob with available officer and force and managed to disperse them. During that brick beating I along with some police personnel received injury on their persons. Myself along with ASI Buddhadeb Mukherjee, C/1376 Sangit Bauri medically treated at Indas B.P.H.C.

Under the above circumstances I started specific case against above noted people's u/s- 143/147/148/153/186/332/353/506 IPC & 3 PDPP Act & 9 MPO Act.
