Sub: Compliant for Trespassing and for Physical Assault to our Security Personnel.

Resected Sir,

We, Shyam Steel Manufacturing Limited, having our Integrated Steel Plant located at Jemua, PO & PS- Mejia, District- Bankura, would like to draw your kind attention that we had hired M/s Delhivery Freight Services Private Limited to provide good vehicle for transporting TMT Bars to our customers/Dealers from the above address. Based on the hire contract, M/s Delhivery Freight Services Private Limited had provided two vehicles bearing no. WB/67C/1177 and WB/67B/7744 for transporting TMT Bars.

At about 9.55 PM on 24th June, 2023, Mr. Narayan Chandra Tewary and Debasish Tewary, claimed themselves as the owners of the vehicles, accompanied by few other unknown people forcibly entered into our premises through our Gate No. 2 in drunken condition and threatened our security personnel at Gate No. 2 namely Sri Shyam Sundar Mishra and Joy Sundar Chowdhuri for releasing their vehicles immediately. While our security personnel were trying to follow the procedure for releasing the vehicles, which obviously took few times. Meanwhile, the so-called owners physically assaulted our security personnel and instructed the drivers of the vehicles namely Sri Biru Kumar Rai and Akhtar Ansari to leave our premises without obeying our release procedure. As, the companion of the so-called owners were surrounded our security personnel, they could not contact any other person for help. In fear, the security personnel finding no alternatives, had released both the vehicles. Soon after, the so-called owners and their companions had left our premises and thereafter our security personnel contacted and narrated the incident.

Under the circumstance, your good office is requested to lodge a formal complaint of this incident and take appropriate action against both the so-called owners namely (1) Mr. Narayan Chandra Tewary and (2) Debasish Tewary, both residents of Tewari Danga, At & PO & PS- Mejia, Dist. Bakura, Pin- 722143 and other unknown miscreants, so that this type of unwarranted incidents shall be prevented inside our plant premises in near future.

Your good office may treat this as an FIR if deem fit and proper.

Your early action in this regard is highly appreciated.
