Sub:- Prayer for lodging complaint.

Sir,

I, ASI/162 Sudhangshu Dey presently posted at Beliatore Police Station do hereby lodge complaint against some (10/12) unknown irate miscreants of Bhattapara village and adjacent villages under Pirraboni G.P., PS- Beliatore Dist.-Bankura, to the effect that, I was engaged in sector duty in c/w Panchayat Election 2023. In course of my said duty at about 15:35 hrs when I arrived at Bhattapara I noticed about 12/15 people, surrounding a group of news reporters and trying to harass them approx 200 mtrs away from Bhattapara School. Immediately I get down from my vehicle and tried to save the reporters from the excited crowd. But some of the agitated mob surrounded the reporters and started to assault them. When the news reporters entered their car to save their lives, the agitated mob from outside attacked them with sticks and started pelting stone. As a result four reporters namely- Milan Karmakar, Swarup Roy, Mritunjoy Das and Aniket Bauri were badly injured and the car was damaged. Somehow we are able to rescue the injured reporters and arranged to send them to Beliatore hospital for treatment.

Therefore I pray a case may kindly be started against this unruly, irate miscreants under proper section of Law as they have violated the provision of the existing Law of the Land.
