Sub- Complain regarding snatching of ballot boxes with polled ballot papers

You may be aware that Poll was conducted on 08.07.2023 for Panchayat General Election 2023 and restrictions u/s 144 Cr.PC was promulgated in the areas of 200 metres of polling stations for peaceful conduct of the poll. But Presiding Officer of Polling station No. & Name, 170 Jagganthpur Jr. Basic School (Room No. 1) reported that some unknown person snatched ballot boxes with polled ballot papers from custody of Presiding Officer during polling (around 14.00 hrs) on 08.07.2023. The ballot boxes with polled ballot paper are still missing.

We are examining the documents and evidences related to this incident.

You are hereby requested to take necessary action in this matter.
