Subject : FIR against Sri Durgapada Pati s/o Sri Mritunjay residing at Patirdanga, Indpur, Bankura

Sir,

I, Shuvendu Shekhar Ghosh, s/o Sreedam Kumar Ghosh, aged 34, presently residing at Indpur, Bankura with permanent address being vill – Kachua, PO – Kankpul, PS – Ashoknagar, District – North 24 parganas, Pin Code – 743272, functioning as Block Land and Land Reforms Officer, Indpur Block, would like to draw your kind attention regarding the following matter.

As per written complaint of Sri Uttam Kumar Pati s/o Yogeswar residing at Patirdanga, Brahmandiha, Indpur, Bankura, *prima facie* it appears that Sri Durgapada Pati s/o Mritunjay residing at Patirdanga, Brahmandiha, Indpur, Bankura, Pin Code – 722173, has attempted to record his name in the Record-of-Rights (RoR) illegally by furnishing fake or forged deed (no being 2913 dated 29.07.1992). Confirmation was received from both ADSR Khatra and DSR Bankura vide their Office Memo No 85 dated 02.12.2022 and 37 dated 23.02.2023 respectively that the aforementioned deed has no match with official records.

Now as per **Order No 213-15/10/2020** dated **17.01.2020** of the **Land & Land Reforms and Refugee Relief & Rehabilitation Department**, you are hereby requested to take penal action against the above noted wrongdoer.

This letter may be treated as FIR.
