## F.I.R.

Sir,

With due respect, I, Pawan Kumar Kedia S/O Late Satyanarayan Kedia resident of Bagangoda, Mejia Bus Stand, P.S. Mejia, Dist-Bankura beg to state as follows:

- 1. That I am a serious Cancer and Kidney patient.
- 2. That on 24.07.2023 at about 12.40 PM when I was busy in my shop at Bagangoda, Near Mejia Bus Stand, Mejia P.S. heard some sound of construction upon our suit property behind my shop and went there to see. All of a sudden my uncle 's son namely Sarvan Kedia S/O Late Biswanath Kedia 2) Aman Kedia S/O Sarvan Kedia 3) Sivam Kedia S/O Sarvan Kedia and Archana Kedia W/O Sarvan Kedia attacked upon me with lathi, Iron Rod, & Plastic pipe and tried to kill me which is clearly appearing from CCTV footage,
  - 3. That hearing my cry mother ran to rescue me, Sarvan Kedia S/O Late Biswanath Kedia 2) Aman Kedia S/O Sarvan Kedia and 3) Sivam Kedia S/O Sarvan Kedia brutally attacked upon my old aged mother Bimala Devi Kedia with Iron Rod with intention to kill as a result whereof she got major injury in her head and chest.

That thereafter Renu Kedia W/O Pravin Kedia (my younger) ran to rescue us but Sarvan Kedia S/O Late Biswanath Kedia 2) Aman Kedia S/O Sarvan Kedia and 3) Sivam Kedia S/O Sarvan Kedia went to rescue me and my mother but Sarvan Kedia S/O Late Biswanath Kedia 2) Aman Kedia S/O Sarvan Kedia and 3) Sivam Kedia S/O Sarvan Kedia attacked upon her brutally and beaten her in leg with lathi and outraged her modesty with intent to disrobe.
- 5. That Sarvan Kedia S/O Late Biswanath Kedia 2) Aman Kedia S/O Sarvan Kedia 3) Sivam Kedia S/O Sarvan Kedia and Archana Kedia W/O Sarvan Kedia also threatened to kill my entire family and abused in filthy language.

Agarwal Hospital now she is in ICCU struggling from death. We are in panic that she may die at any point of time.

Under the above facts and circumstances You are therefore requested to please take necessary steps so that Sarvan Kedia S/O Late Biswanath Kedia 2) Aman Kedia S/O Sarvan Kedia 3) Sivam Kedia S/O Sarvan Kedia and Archana Kedia W/O Sarvan Kedia may be punished according to law.
