To The Inspector-in-Charge Raipur Police Station Bankura

Sir,

In producing herewith the arrested accused persons namely Prasenjit Bera @ Babu (36 Yrs) S/O- Nilkanta Bera of Raipur Madhampara PS – Raipur Dist. Bankura along with seized 03 (19.2 Kg) Bharatgas Cylinder fully loaded with LPG, 01 (14.2 Kg) Bharatgas cylinder fully loaded with LPG, 01 (14.2 Kg) H.P.Gas cylinder fully loaded with LPG, 01 Empty 14.2 Kg Bharatgas Cylinder, 03 Empty 14.2 Kg H.P.Gas Cylinder, 01 Empty 08.2 Kg Bharatgas cylinder with 01 regulator, 01 four feet pipe, and 01 refilling apparatus to the effect that today on 21.08.2023 at 14:05 hrs received a source information that illegal LPG business are running at Sabuj Bazar, Raipur under Raipur PS Dist. Bankura and accordingly with kind permission of superiors, myself along with C/688 Susil Hembram, C/127 Angshuman Sahana being accompanied by Insp. DEB, Bankura vide DEB Bankura CC No 173/23 dtd 21.08.2023 and arrived at Raipur PS and submitted a requisition for Police assistance which refers to Raipur PS GDE No 891 dated 21.08.2023 left for the place with Govt Vehicle No. WB67B/6136 assisted by Raipur PS mobile van officer SI Mritunjoy Patra with force.

At about 17.45 hrs we arrived at Sabuj Bazar, Raipur, cordoned the shop cum godown of Prasenjit Bera @ Babu as identified by the source. It is to mention that the Prasenjit Bera @ Babu was running his business in a rented shop cum godown of Govinda Kar S/O Lt. Manik Ch. Kar of Vill- Raipur Sabuj bazaar, PS- Raipur, Dist- Bankura, Called two independent witnesses namely Govinda Kar S/O Lt. Manik Ch. Kar of Vill- Raipur Sabuj bazaar, PS- Raipur, Dist- Bankura (Building owner) & Shaktipada Mahapatra S/O Lt. Bijoy Mahapatra of Vill- Raipur Sabuj bazaar, PS- Raipur, Dist- Bankura and held raid in presence of witnesses from 17.55hrs to 18.55hrs and recovered 03 (19.2 Kg) Bharatgas Cylinder fully loaded with LPG, 01 (14.2 Kg) Bharatgas cylinder fully loaded with LPG, 01 (14.2 Kg) H.P.Gas cylinder fully loaded with LPG, 01 Empty 14.2 Kg Bharatgas Cylinder, 03 Empty 14.2 Kg H.P.Gas Cylinder, 01 Empty 08.2 Kg Bharatgas cylinder with 01 regulator, 01 four feet pipe, and 01 refilling apparatus. I asked the accused to produce valid papers in respect of filling domestic/commercial LPG Cylinder to the LPG Car from his shop or any valid documents or Licence for storing and doing businesses of LPG. He stated that he collected those cylinders from different places. He also stated that he is doing this illegal business in clandestine manner at the said place for long times without holding any licence or authority from the concern companies and getting commission from the LPG dealers and noted above. All those items were seized under proper seizure list from in-between 17.55 hrs to 18:55 hrs duly signed by the witnesses and arrested him after observing all legal formalities for illegal storing and using domestic cylinders for business purpose without any license/valid documents.

There are every reason to believe that arrested accused procured those domestic cylinders from the authorized dealers as noted above for the purpose of running their unauthorized business depriving the legitimate domestic consumers for wrongful gain and profit.

The LPG distributors as noted above are entrusted with the property of the respective company and dishonestly misappropriates, uses, disposes that property (LPG Cylinders) to others who are not a bonafide a customers in violation of directions of law prescribing the mode in which such trust is to be discharged but with the connivance of the above noted arrested person disposes LPG Cylinders for which the original customers are suffered. Hence, he committed criminal breach of trust and also cheating the bonafide customers with knowledge that wrongful loss may ensue to person whose interest the LPG distributors are bound to protect as well as deliver such property (LPG Cylinder) to another person who is not a bonafide customer.

Hence I pray that a specific case may kindly be started under proper section of law against the arrested accused person namely Prasenjit Bera @ Babu (36 Yrs) S/O- Nilkanta Bera of Raipur Madhampara PS – Raipur Dist. Bankura alleged distributors for the offence he has committed.
