Sub: Prayer for lodging FIR.

Sir,

In producing herewith arrested accused person namely Asit Mahata (26 yrs) S/o Banamali Mahata of Vill-Krishnapur, P.O. – Sukhadali, PS-Sarenga, Dist-Bankura along with the following seized articles as (1) MC Dowell's no-1 Celebration RUM -02 bottles containing 180 ML each, value of Rs-150 X 02 =300/- (2) Old Monk XXX RUM-02 bottles containing 750 ML each, value of Rs-560X 02=1120/- (3) Kingfisher Strong 30 bottles containing 650 ML each, value of Rs- 135 X 30=4050/- (Total value of seized amount Rs. 5470/-) under proper seizure list duly signed by arrested accused person and the other witnesses. I, ASI Bikash Banerjee of Sarenga P.S do here by lodged a complaint against him. I beg to state that, on 05.08.2023 at 20:35 hrs in course of RT mobile duty received a credible source information that, at P. More under Neturpur GP one person is selling country spirit & foreign liquor illegally to the customers in exchange of money. Accordingly I informed the matter to I/C Sarenga PS and as per direction myself along with RM/2284 Narayan Pradhan, RM/2421 Kesias Karjee & RM/2397 Prem Tshring Lepcha left for P.More to work out the information, this refers to Sarenga PS GDE No-214 Dated-05.08.2023 & CC No- 2428/23 Dated-05.08.2023. Myself along with force arrived at P.More and kept our Govt. vehicle at a reasonable distance, moved towards the Pan shop of Asit Mahata as shown by the source. We surrounded the Pan shop and found one person is selling the foreign liquor to the customers, seeing the police party the persons who were consuming liquor managed to flee away but we apprehended one person who is selling foreign liquor. We searched the Pan shop thoroughly and found the aforesaid articles. I asked him regarding any valid document or license for stocking foreign liquor and selling the same to the customers but he failed to produce any valid documents in this regard. Accordingly I seized the same under proper seizure list and labeled duly signed by him and other witnesses. On interrogation he disclosed his identity Asit Mahata (26 yrs) S/o- Banamali Mahata of Vill-Krishnapur, P.O. – Sukhadali, PS-Sarenga, Dist-Bankura. As he possessed and selling foreign liquor by violating the provision of Bengal Excise Act hence I arrested the aforesaid person after maintaining all legal formalities regarding arrest.

Under the above circumstances, I pray a case may kindly be registered against him under proper section of law, as he possessed and selling the foreign liquor by violating the provision of Bengal Excise Act.
