Sir,

In producing herewith with one Tractor bearing Engine No-DC4007/SEH11066 & Chassis No-MBNAW53ADNCH fitted with trolley loaded with sand without proper documents & having no registration number plate of the said vehicle.

Most respectfully I, SI Chandra Sekhar Mandal of Sarenga P.S. beg to report that, on 27.08.2023 at about 08:05 hrs I along with (1) NVF/0717 Bablu Pal (2)HG/84 Nayan Rajak were going to Majuria under Sarenga PS for performing special morning mobile duty vide CC No-2685/23 Dated-27.08.2023 at that time I found one Tractor fitted with trolley loaded with sand & having no registration number plate of the said tractor which was coming towards Majuria Hattala from the bank of Kangshabati river side. The driver of the said tractor ran away after seeing the police party. After that I searched every possible places to detain the said driver but unable to trace him. On being asked to the local people regarding owner of the said tractor and they stated that, Basak Pratihar (Owner of the Tractor) S/o-Khokan Pratihar of Vill- Deuli, PO-Penchara Deuli, PS-Sarenga, Dist-Bankura and I found that, tractor having Engine No-DC4007/SEH11066 & Chassis No-MBNAW53ADNCH29155. Consequently, I met with Basak Pratihar and he stated that, he is the owner of the said detained tractor & sand loaded trolley. I asked him to produce valid document regarding ownership of his tractor & trolley along with valid document for carrying & transporting of sand. But he failed to produce any kind of valid paper of the said tractor fitted with trolley & also failed to produce document regarding carrying & transporting of sand. He also stated that, he has procured the sand and loaded into the trolley illegally from the bank of the river Kangshabati, near Majuria village. So he has no proper document relating to carrying sand. I informed the entire fact to I/C Sarenga PS and as per his direction I seized the said tractor along with trolley loaded with sand under proper seizure list duly signed by the available witnesses and I also took away the said tractor fitted with trolley loaded with sand from Majuria village and kept in PS safe custody.

During preliminary enquiry it was learnt that, the driver of the said tractor has procured the sand illegally in connivance of the owner of the said tractor for the benefit of their own, causing loss of Govt. Revenue. So I submitted a type written complaint against the driver & the owner of the said Tractor fitted with trolley loaded with sand.

Considering above facts & circumstances, I pray for starting a FIR under proper section of law against the driver & the owner of the said Tractor fitted with trolley loaded with sand for procuring, carrying & transporting the sand illegally and arrange for its investigation.
