In producing herewith the following article i) PVC Cable two Core single wire 06 mtr (Approx) with hooking device seized under proper seizure list, duly signed by available witnesses, I Sri Rajsekhar Gorai, (Age - 48 Years) S/O - Sri Narugopal Gorai, Station Manager of Simlapal CCC do hereby lodge complaint against Badal Roy, S/O Lt Habu Roy, Residence of Krishnapur, PO-Pathardoba, PS - Simlapal to the effect that to day (08.08.2023) at about 12.10 P.M acting on a tip -off myself accompanied by

had gone to village Krishnapur to work out the information. Around 02.05 P.M. we reached at village Krishnapur and inspected the electric line. During inspection the owner cum occupier Badal Roy has been found stealing electricity dishonestly at his Commercial premises (Poultry Firm) by way of direct hooking from nearby LTOH line and has caused financial loss to WBSEDCL. The load is assessed 0.380 KW. The inspection team left the premises at about 02.25 P.M.

Thus the owner cum occupier Badal Roy has violated the provision of section 135(I)(a) of Electricity Act 2003(Amendment 2007).

Hence I seized the above noted article under proper seizure list duly signed by available witnesses, following disconnection the electric line by removing hooking device and produce before you with a request initiate a case U/S- 135(I) (a) of Electricity Act 2003(Amendment 2007) against Badal Roy, S/O Lt Habu Roy, Residence of Krishnapur, PO-Pathardoba PS - Simlapal, Dist - Bankura and arrange for its investigation.

The result of the investigation may kindly be communicated after its completion for onward action.
