In producing herewith the following article i) PVC Cable two Core single wire 04 mtr (Approx) with hooking device seized under proper seizure list, duly signed by available witnesses, I Sri Rajsekhar Gorai, (Age - 48 Years) S/O - Sri Narugopal Gorai, Station Manager of Simlupal CCC do hereby lodge complaint against Uttam Roy, S/O Anil Roy, Residence of Krishnapur, PO-Pathardoba, PS - Simlupal to the effect that to day (08.08.2023) at about 12.10 P.M acting on a tip -off myself accompanied by

had gone to village Krishnapur to work out the information. Around 02.30 P.M. we reached at village Krishnapur and inspected the electric line. During inspection the owner cum occupier Uttam Roy has been found stealing electricity dishonestly at his Domestic premises by way of direct hooking from nearby LTOH line and has caused financial loss to WBSEDCL. The load is assessed 0.280 KW. The inspection team left the premises at about 02.55 P.M.

Thus the owner cum occupier Uttam Roy has violated the provision of section 135(I)(a) of Electricity Act 2003(Amendment 2007).

Hence I seized the above noted article under proper seizure list duly signed by available witnesses, following disconnection the electric line by removing hooking device and produce before you with a request initiate a case U/S- 135(I) (a) of Electricity Act 2003(Amendment 2007) against Uttam Roy, S/O Anil Roy, Residence of Krishnapur, PO-Pathardoba PS - Simlupal, Dist - Bankura and arrange for its investigation.

The result of the investigation may kindly be communicated after its completion for onward action.
